

AB540 Nonresident Supplemental Tuition Exemption

Application and Affidavit

for eligible California high school graduates

Complete and sign this form to request exemption from Nonresident Supplemental Tuition differential charged to nonresident students. Once you are determined to be eligible for the exemption, you will continue to receive the exemption as long as you fulfill the requirements listed below or the University no longer offers this exemption, whichever occurs first.

Applying for the exemption does not in any way alter your responsibility to pay on time any nonresident tuition and associated fees that may be due before your eligibility is determined.

APPLICATION

I, the undersigned, am applying for a University of California Nonresident Supplemental Tuition Exemption for Eligible California High School Graduates and declare that ALL of the following apply to me (check YES or NO boxes):

- Yes No 1. I have attended high school in California for three or more years; OR I have attained the equivalent of three or more years of full-time high school course work in fewer than three years AND I have attended a combination of elementary, middle and/or high schools in California for a total of three or more years; AND
- Yes No 2. I have graduated from a California high school or have attained the equivalent thereof, such as a High School Equivalency Certificate, issued by the California State GED Office or a Certificate of Proficiency, resulting from the California High School Proficiency Examination; and
- Yes No 3. I am NOT a non-immigrant alien. [Non-immigrants, as defined by federal law, have been admitted to the United States temporarily and may have been granted one of the following visas A, B, C, D, E, F, G, H, I, J, K, L, M, N, O, P, Q, R, S, T, TN, TD, U, V, TWOV, and NATO].

You must submit, as part of this Application and Affidavit, your *official high school transcript(s)* validating graduation from a CA high school and the requisite years of CA high school attendance or equivalent. If total attendance at all CA high schools is less than three years, you must also submit additional transcripts validating three years of attendance at California school(s) during K-12. (Entering freshmen who will submit transcripts to the Office of Admissions are normally not required to submit a second high school transcript to the Registrar’s Office)
